M. The Company has engaged the services of CDSL as the authorized agency to provide the e-voting as per instruction below:

The instructions for shareholders voting electronically are as under:

(i) The voting period begins on 22.03.2019 (10.00 a.m.) and ends on 24.03.2019 (5.00 p.m.). During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date 18.03.2019, may cast their vote electronically.

- (iv) Now Enter your User ID


