**कुल कर्ज घटकर 21 फीसदी हुआ**  
अडाणी समूह के पास उपलब्ध नकदी को ध्यान में रखते, तो उसपर मार्च, 2022 में 1.88 लाख करोड़ रुपये का सकल कर्ज और 1.61 लाख करोड़ रुपये का शुद्ध ऋण था। समूह ने कहा कि वित्त वर्ष 2015-16 में उसकी कंपनियों के कुल कर्ज में सार्वजनिक बैंकों से लिए गए कर्ज का अनुपात 55 प्रतिशत पर था लेकिन वित्त वर्ष 2021-22 में यह घटकर कुल कर्ज का सिर्फ 21 प्रतिशत रह गया।
